Scope of Authorisation

Repair/Overhaul/Modification/Test of aircraft components as authorised by Qantas.

Conditions of Approval

- 1) To carry out only those repairs/modifications listed in the Original Equipment Manufacturer's (O.E.M.'s) Component Maintenance Manuals. Deviations from this condition require prior written authorisation by a Qantas, Civil Aviation & Safety Authority Approved Person.
- 2) The use of 'FAA Minor & / or Major Repairs', require prior written authorisation by a Qantas, Civil Aviation & Safety Authority Approved Person.
- 3) All parts used in the Repair/Overhaul process must be new O.E.M. parts or PMA parts that have their PMA part number referenced in the relevant O.E.M. CMM or IPC. The use of any other alternate part requires prior written approval from Qantas.
- 4) Exchange parts are not permitted without prior written approval from Qantas.
- 5) The **majority** of the work being carried out on a Part / Component **must** be carried out by your organisation. If your organisation requires to sub-contract the **majority** of the work to another Repair Vendor, prior written approval must be obtained from Qantas Quality & Safety – Aircraft Maintenance Services.
- 6) The company shall maintain a current NZCAA Part 145.
- 7) All repaired parts returned to Qantas must have an NZCAA Form One supplied.
- 8) Qantas Quality & Safety – Aircraft Maintenance Services reserves the right to audit your facility at any time during the term of this approval.
- 9) All repaired components returned to Qantas must have a 'Shop Findings Report' when requested.

This approval shall remain valid until amended, suspended or withdrawn by Qantas.

Your performance as a Supplier will be subject to ongoing evaluation of compliance with this approval and quality requirements.
